1. Entrants will bowl four games across eight lanes, low game to be discarded.
2. Certified average requirements:
 - (a) Highest league average at the end of the previous season (2023-24) from the association where you are a member. If none, final average from ending season (2022-2023). If none, current league average of 21 games as of tournament date. If none, summer 2023 league average. All others will bowl scratch.
 - (b) It shall be each bowler's responsibility to verify the accuracy of her submitted average. Failure to use the correct average will disqualify scores if submitted average is lower than the correct average, or base winnings on the submitted average if it is higher.
 - (c) An award shall be presented to the winner of the highest net game and net series rolled in the tournament out of the money. In case of any ties, prize money will be added together and divided equally.
3. USBC rules 319a - 319e will apply.
4. This tournament is restricted to current members of the Westchester Women's 600 Club and certified through the United States Bowling Congress.
5. A replacement will be permitted, as long as she is a current member of the Westchester 600 club and certified through the United States Bowling Congress.
6. Tournament entry fee is non-refundable.
7. Bowlers are requested to wear suitable attire. (600 club bowling shirts, if possible)
8. All entries postmarked the first post office business day following the entry closing will be accepted. Walk-ons permitted up to one half hour before tournament start as long as there are lanes available.
9. Entry fee must be remitted by check, money order, or bank draft made payable to:
WESTCHESTER 600 BOWLING CLUB. THERE WILL BE A \$30 CHARGE IF ANY CHECK IS RETURNED FOR INSUFFICIENT FUNDS.
10. Westchester 600 and USBC membership cards must be presented at the tournament.
